#### Adelaide Goodno: Temperance and Suffrage Advocate

The subject of this article was the great-great grandmother of GFA member Pat Archer. T(herese) Adelaide was married to Dr. Charles Franklin Goodno, a descendant of the Immigrant Thomas. Adelaide was active in the Woman's Christian Temperance Union, eventually serving as state president of the WCTU in North Carolina. She also campaigned for the right of women to vote, and lived to see the ratification of both Prohibition (1919) and the Enfranchisement of Women (1920).

#### Fifty Years of Loving Life in a Historic Landmark Home

GFA Life member Phyllis Goodenough recently celebrated 50 years of ownership of her dream home, in Neenah, WI. Known as the "Reverend Jens N. Jersild House," it was built in 1886 and is on both the National Register and the Wisconsin State Register of Historic Places, as well as being an official "Neenah Landmark." Phyllis is a descendant of the Immigrant Thomas.

Clarence K. Smith, Jr. (26 May 1933-2019). Late husband of GFA Life member Fran Smith, who is a descendent of the Immigrant Capt Edmund Goodenow.

Elmer Hall Palmer (25 Dec 1926-15 Sep 2021). A resident of Rhode Island and a Capt Edmund descendant.

Two Historic Goodnow Sites in Princeton, MA (located about 2 miles apart)

The Historic Goodnow Inn – The house and barn erected by Edward and Lois Goodnow in the 1790s still stands, and is included in a Historic District and a Wildlife Sanctuary. In 1823 the house was opened as a stagecoach tavern.

The 1760 Peter Goodnow House – Presently on the market (for \$849,900), the house was built by Peter Goodnow (1710-1783). After moving from Sudbury, MA to Princeton, MA, he served as a selectman twice and town assessor and treasurer. A later owner of the house made changes to the structure to more closely resemble the Goodnow Inn.

Goodnow Cases Argued Before the U.S. Supreme Court

Several suits brought by Edward K. Goodnow, a citizen of New York, were argued before the U.S. Supreme Court, dating from April 1886 through October 1893. Edward K.

Goodnow *may possibly be* Edward Kirk Goodnow (1844-1886), a banker and descendant of the Immigrant Capt Edmund.
