John T. Goodnough Receives GFA Distinguished Service Award

John T., as he is known, joined the GFA in 1993 and has been a faithful and active member since, having served as the organization's Vice President and President, and coordinating three different GFA Reunions. On October 16, 2022, via Zoom, he was presented with the Distinguished Service Award, in recognition of his service and in gratitude for his dedication to the collection, researching, compiling and publishing of information on Goodenow family members who served in the American Civil War (1861-65) and in World War I (1914-18). These initiatives have deepened our understanding and appreciation of previous generations and resulted in vital and valuable contributions to and insights into the family history.

Westward Wagons by Russ Goodenough Published

Russ Goodenough is a Life member of the GFA and a descendant of the 1638 immigrant Thomas Goodenow. After attending the 2018 GFA Reunion in Sudbury, MA, he became inspired to document his Goodenow ancestry and trace the family's history from England to Massachusetts to New York and westward. Though he concentrates on his family line, the vast majority of the book (of 500+ pages) covers the experiences common to all the family lines. Forty Years of GHOSTS, Part 4

Reprint of an Editors' Comments column from the November 2005 issue (Vol. 23 #4) of *Goodenows' Ghosts*, written by Jan and Bill Groenier, co-editors of Ghosts from 1996-2006.

A Walking Tour through Historic Goodenow, Illinois, 24 September 2022 at 11:00 a.m.

The former town of Goodenow, Illinois, was founded in 1872 by George Washington Goodenow, a descendant of Capt. Edmund, making 2022 the settlement's 150th anniversary. A historic Walking Tour was conducted on September 24, sponsored by the Crete Area Historical Society, with assistance from the Will County Historical Society. Two GFA members were able to travel to Goodenow and join the walking tour; Life member Christine Banvard-Fox summarized the highlights and provided photographs. The town prospered due to a railroad line, but was devastated by a cyclone in 1917 and suffered two major fires in the 1930s. It is now a rural enclave prized for its bucolic and peaceful setting, with a population of 76.

Pamela Peirce Seeks a Relative of Elizabeth Doggett Goodnow Wicks; she has photographs and other mementos to pass along to any interest Goodenow descendant

This family member's profile was written by her granddaughter, Pamela Peirce. Elizabeth Doggett Goodnow Wicks (22 Dec 1874-8 Dec 1929) was a descendant of Capt Edmund. She and her husband, a Unitarian minister, settled in Indianapolis. There, the couple took in four foster children, adopting two of them. Pamela Peirce, the author, is the daughter of one of the foster children. She possesses photographs and other memorabilia related to Elizabeth, and wishes to offer the items a blood relation of Elizabeth.

Veterans' Day Salute to Two Career Military Officers

John E. Goodnow (LtCol-Ret) and Purple Heart Recipient

A Capt. Edmund Goodenow descendant; he served in Vietnam and received the Purple Heart after being wounded in combat in 1968. He graduated from West Point and his military career stretched from 1967-1993. Post-retirement, he worked in higher education and on projects in Africa overseen by the U.S. Department of State and the Department of Defense.

Gunnery Sergeant Gabriel Green, USMS (and future Veteran)

The attacks on New York City and the Nation's Capital, on September 11, 2001, propelled a 10-year old Gabriel Green to vow to join the U.S. Marine Corps. Nine years later, he fulfilled that vow and he has served with honor across the world. The article was contributed by GFA member Laurice McCord, mother of Gabe Green and descendant of the Immigrant Capt. Edmund.
