Goodenoughs of South Africa Pay 1911 Visit to the Famous Battle Creek Sanitarium

Rev. Herbert Delos Goodenough (1852-1927) and his wife Caroline Leonard Goodenough (1856-1946) served as Christian missionaries in South Africa for three decades, beginning in the 1880s. In 1911 Rev. and Mrs. Goodenough, and a daughter Caroline Lilian (1891-dec.), were visitors to the Battle Creek Sanitarium (headed by Dr. John Harvey Kellogg). Three issues of the Sanitarium's weekly newspaper, *The Battle Creek Idea*, detail the activities of the family members.

After 70 Years in Downtown Norman, Goodno's Jewelry Celebrates New Location

In July 2017, Goodno's Jewelry of Norman, OK, relocated to a newer section of the city. The firm was founded in 1944 by John Goodno (1915-); beginning in 1980, John Goodno's daughter and son-in-law (Barbara and Mack McGuckin) owned and operated the store; in 2017, ownership passed to the third generation, John Goodno's grandson Randy McGuckin.
